

## OFFICIAL SWEEPSTAKES RULES

**NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES WHO ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. THE PROMOTION IS INTENDED FOR LOCATIONS WHERE SWEEPSTAKES ARE NOT PROHIBITED BY LAW AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY, UNITED STATES LAW. 1. **PROMOTION PERIOD:** The entry period for the "Intel vPro Sweepstakes" ("**Sweepstakes**") begins on April 28, 2021 at 9:00 a.m. Central Time and ends on July 6, 2021 at 5:00 p.m. Central Time (the "**Sweepstakes Period**"). One (1) weekly winner will be randomly selected within every Wednesday starting May 5, 2021 from all eligible entries received within the prior week as more fully set forth below. One (1) winner will be selected every third week, starting May 19, 2021. One grand prize winner, who participated in at least five (5) weeks and provided a short answer, will be selected at the end of the Sweepstakes Period. By participating in the Sweepstakes, each entrant (or his/her parent or legal guardian if entrant is deemed a minor in his/her state of residence) unconditionally accepts and agrees to comply with and abide by these Official Sweepstakes Rules and the decisions of Spiceworks, Inc. 2. **ELIGIBILITY:** Open only to Spiceworks Registered Community Users who are legal residents of United States (excluding residents of locations where sweepstakes are restricted or not permitted), and who are 18 years of age or older as of date of entry. If you do not wish to hear from them, just let them know or simply do not enter the Sweepstakes.
