

## OFFICIAL SWEEPSTAKES RULES

**NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Please note that you must return each week and answer the new question for a chance to be entered into that week's drawing. The question will be updated every Monday for that week.

Please note that the Sweepstakes registration form includes contact information and Cisco may contact you. If you do not wish to hear from them, just let them know or simply do not enter the Sweepstakes.
